## Request for Proposals 81-4-25

### Assessment of Enabling Framework for Innovative Entrepreneurship in Bosnia and Herzegovina

**Location:** Bosnia and Herzegovina

**Reporting to:** Project Manager, Future Minds Lab Initiative

#### 1. Introduction

The Sarajevo School of Science and Technology (SSST) invites qualified incorporated entities (consulting firms, research institutes, or consortia) to submit proposals for the implementation of a comprehensive Assessment of the Enabling Framework for Innovative Entrepreneurship in Bosnia and Herzegovina (BiH). The purpose of this assessment is to identify barriers and opportunities within the legal, institutional, and financial environment affecting entrepreneurship, and to recommend evidence-based policy and structural improvements to foster a more inclusive and dynamic entrepreneurial ecosystem.

#### 2. Background

The Global Innovation Index for 2024 ranks BiH 37th among the 39 European nations.<sup>1</sup> This alarming statistic illustrates a consistent lack of investment in research and innovation by the country, negatively and significantly impacting the international competitiveness of the BiH industry. The adoption of technology, and investment in innovation, remain problem areas while BiH institutional performance in support of innovation is assessed especially poorly. All of these factors inhibit business performance and restrict companies' ability to create innovative products and services that can penetrate international markets. The ability of BiH businesses to take full advantage of opportunities presented by the twin green and digital transitions is likewise adversely affected, limiting emerging market and investment opportunities. Against this background, the FutureMinds Lab Initiative, funded under the auspices of the Sustainable Economic Development and Employment Promotion (SEDEP) Program - implemented by GIZ in BiH - works across two parallel streams to address challenges to a more innovative economy for BiH by creating the necessary market conditions and a steady supply of innovation, entrepreneurship and digital skills for the future.

Under the first programmatic stream, the Project will create an enabling space for innovation by first initiating and fostering mutually beneficial relationships between the innovator community and the private sector. This will entail the implementation of detailed needs assessments for key industries to identify points of entry for green innovation in the form of new products, services and/or processes. The

findings will be used to mobilize the innovator community to offer new solutions through hackathons that will generate viable product or service ideas, to be further developed and ultimately implemented in partner SMEs.

Under the Project's second programmatic stream, the Project will build capacities to power the innovation ecosystem through the sustainable development of green, digital and entrepreneurial skills. This will include developing entrepreneurship skills for emerging innovators through a targeted training and mentoring program, as well as three tailor-made service lines. In order to inform said activities, the Project is commissioning a study of the enabling framework and the barriers faced by innovative entrepreneurs in BiH.

### 3. Objective

The main objective of this assignment is to:

- Assess enabling environment for innovative entrepreneurship in BiH, including legal, institutional, financial, and educational components;
- Identify systemic constraints and coordination gaps among public, private, international, and civil society actors;
- Benchmark BiH's entrepreneurship environment against regional and EU frameworks;
- Provide concrete, actionable policy recommendations.

### 4. Tasks

The assignment will include but not be limited to the following components:

- **Policy and Regulatory Review:** Analyze relevant laws, regulations, and procedures affecting entrepreneurship (e.g., business registration, licensing, taxation) across all relevant levels in BiH.
- **Institutional Mapping:** Identify public and private stakeholders (ministries, chambers, incubators, etc.) and their roles in the ecosystem.
- **Financial Ecosystem Analysis:** Assess availability and accessibility of funding sources for startups and SMEs (loans, equity, grants, guarantees).
- **Human Capital and Education:** Evaluate the presence and effectiveness of entrepreneurship education, training programs, and workforce readiness.
- **Infrastructure and Services:** Assess the support services available to entrepreneurs, such as incubators, accelerators, and digital infrastructure.
- **Stakeholder Consultations:** Conduct interviews and focus groups with entrepreneurs, support organizations, and policymakers - no fewer than 20 stakeholders from across the ecosystem must be included in consultation.
- **Benchmarking:** Compare BiH with selected peer countries (Western Balkans and EU) using recognized indices and indicators.

- Entrepreneurship and SME policy;
- Public policy and regulatory analysis;
- Economics or finance;
- Data collection and stakeholder engagement.

Demonstrated knowledge and awareness of local context of BiH (language skills and institutional knowledge) is mandatory.

Proposals must be submitted in English and should include:

1. **Technical Proposal that will demonstrate:**
  - Understanding of the assignment with proposed methodology and work plan;
  - Team composition and CVs;
  - Past experience with similar projects.

#### 1. Uvod

Sarajevska škola za Nauku i Tehnologiju (SSST) poziva kvalifikovane registrovane subjekte (konsultantske firme, istraživačke institute ili konzorcije) da podnesu prijedloge za implementaciju sveobuhvatne procjene okvira za podršku inovativnom preduzetništvu u Bosni i Hercegovini (BiH). Svrha ove procjene je identifikacija prepreka i mogućnosti unutar pravnog, institucionalnog i finansijskog okruženja koje utiče na preduzetništvo, te preporuka politika zasnovanih na dokazima i strukturnih poboljšanja kako bi se podstakao inkluzivniji i dinamičniji preduzetnički ekosistem.

#### 2. Kontekst

Globalni indeks inovacija za 2024. godinu rangira BiH na 37. mjesto među 39 evropskih zemalja.<sup>2</sup> Ova zabrinjavajuća statistika ukazuje na konstantan nedostatak ulaganja države u istraživanje i inovacije, što negativno i značajno utiče na međunarodnu konkurentnost industrije u BiH. Usvajanje tehnologije i ulaganje u inovacije i dalje predstavljaju problematična područja, dok se institucionalna podrška inovacijama u BiH ocjenjuje posebno loše. Svi ovi faktori ograničavaju poslovne performanse i smanjuju sposobnost kompanija da razviju inovativne proizvode i usluge koje bi se mogle plasirati na međunarodna tržišta. Takođe, sposobnost bh. preduzeća da u potpunosti iskoriste prilike koje nude zelena i digitalna tranzicija dodatno je narušena, čime se ograničavaju potencijalna tržišta i investicione mogućnosti. U tom kontekstu, Inicijativa FutureMinds Lab, koja se finansira u okviru Programa za održivi ekonomski razvoj i promociju zapošljavanja (SEDEP) – koji u BiH implementira GIZ – djeluje kroz dvije paralelne programske oblasti s ciljem rješavanja izazova na putu ka inovativnijoj ekonomiji Bosne i Hercegovine, kroz stvaranje odgovarajućih tržišnih uslova i kontinuirane ponude inovacija, preduzetničkih i digitalnih vještina za budućnost.

U okviru prve programske oblasti, Projekat će stvoriti poticajno okruženje za inovacije tako što će prvoinicirati i podsticati uzajamno korisne odnose između zajednice inovatora i privatnog sektora. To će uključivati provedbu detaljnih analiza potreba ključnih industrija s ciljem identifikacije ulaznih tačaka za zelene inovacije u vidu novih proizvoda, usluga i/ili procesa. Dobijeni nalazi će se koristiti za mobilizaciju zajednice inovatora kako bi ponudili nova rješenja putem hakatona, koji će generisati izvodljive ideje za proizvode ili usluge, koje će se dalje razvijati i na kraju implementirati u partnerskim malim i srednjim preduzećima (MSP).

U okviru druge programske oblasti, Projekat će jačati kapacitete za osnaživanje inovacijskog ekosistema kroz održivi razvoj zelenih, digitalnih i preduzetničkih vještina. To će uključivati razvoj preduzetničkih vještina za nove inovatore putem ciljanog programa obuka i mentorstva, kao i kroz tri posebno osmišljene linije usluga. Kako bi se ove aktivnosti utemeljile na relevantnim podacima, Projekat naručuje studiju o okviru za podršku i preprekama s kojima se suočavaju inovativni preduzetnici u BiH.

### 3. Cilj

Glavni cilj ovog zadatka:

- Procijeniti podsticajno okruženje za inovativno preduzetništvo u BiH, uključujući pravne, institucionalne, finansijske i obrazovne komponente;
- Identifikovati sistemska ograničenja i nedostatke u koordinaciji između javnih, privatnih, međunarodnih i aktera civilnog društva;
- Uporediti preduzetničko okruženje u BiH sa regionalnim i EU okvirima;
- Pružiti konkretne, primjenjive preporuke za javne politike.

### 4. Zadatak

Zadatak će uključivati, ali neće biti ograničen na sljedeće komponente:

- **Pregled politika i propisa:** Analizirati relevantne zakone, propise i procedure koji utiču na preduzetništvo (npr. registracija preduzeća, licenciranje, oporezivanje) na svim relevantnim nivoima u BiH.
- **Institucionalno mapiranje:** Identificirati javne i privatne zainteresirane strane (ministarstva, komore, inkubatore itd.) i njihove uloge u ekosistemu.
- **Analiza finansijskog ekosistema:** Procijeniti dostupnost i pristupačnost izvora finansiranja za startupove i mala i srednja preduzeća (krediti, kapital, grantovi, garancije).
- **Ljudski kapital i obrazovanje:** Procijeniti prisutnost i učinkovitost obrazovanja o poduzetništvu, programa obuke i spremnosti radne snage.
- **Infrastruktura i usluge:** Procijeniti usluge podrške dostupne preduzetnicima, kao što su inkubatori, akceleratori i digitalna infrastruktura.
- **Konsultacije sa zainteresovanim stranama:** Provesti intervjuje i fokus grupe sa preduzetnicima, organizacijama za podršku i kreatorima politika - u konsultacije mora biti uključeno najmanje 20 zainteresovanih strana iz cijelog ekosistema.
- **Benchmarking:** Uporediti BiH s odabranim sličnim zemljama (Zapadni Balkan i EU) koristeći priznate indeksе i indikatore.
